The Rehfeldt Group includes Lai Fu Trading Co., Ltd. and Air Associates Ltd. in Taipei, Taiwan, Lai Fu Luxembourg SA in Luxembourg and others. The company has offices in Taiwan, Los Angeles, Abu Dhabi, Moscow and Luxembourg.

In 1964, Edward J. Rehfeldt Sr. and Edward J. Rehfeldt III moved to Taiwan from the USA to establish one of Taiwan's very first electronic manufacturing companies. They went on to build an international corporation effectively linking Taiwan with world markets while helping international firms market and ship their products in and from Taiwan. The Rehfeldt's founded the TUSICO Ltd., the first private Foreign Investment approved in Taiwan, focusing on the areas of manufacturing, services, and trading.

The Rehfeldt Group soon became leaders in developing Taiwan's worldwide transportation specializing in the airline, air-cargo, aircraft, and rail industries. The Rehfeldt Group's Air Associates Ltd. opened the first air passenger charter services in 1965 and the first air cargo charter services the following year in 1966. The Rehfeldt Group's Lai Fu Trading Co. Ltd. was the pioneer in bringing the first U.S. consumer products, mainly RCA color TV, Amana and Sears appliances to Taiwan.

From 1969 the Rehfeldt Group initiated the first scheduled Transpacific air cargo services from Taiwan. In 1978, Air Associates Ltd. was responsible for arranging the first ever scheduled cargo rights in the world for Cargolux Airlines of Luxembourg with routes from Taiwan to the Middle East and Luxembourg. In 1982, Air Associates was instrumental in negotiating a joint venture between Cargolux and Taiwan's China Airlines giving China Airlines its first traffic rights in Europe.

The company was an initiator of the joint design, development, test and manufacture program with Taiwan's AIDC and General Dynamics that produced the IDF, Ching Kuo fighter aircraft. The company also initiated a joint development of phased array radar and other systems between RCA and Taiwan's Chung Shan Institute of Science and Technology, and a tank development for General Dynamics with the Taiwan Army. The company has sold more than eighty commercial aircraft to six airlines, three leasing companies and the government for McDonnell Douglas and Bombardier, one hundred fifty F-16 aircraft for General Dynamics Ft. Worth Division (now Lockheed Martin Aeronautics).

At present, the Rehfeldt Group has operations in many countries including the United States, the United Arab Emirates, Luxembourg and Russia offering a wide range of sales, marketing, and consulting services in the commercial aerospace, railway, air cargo transportation, engineering and construction

industries.

The Rehfeldt Group prides itself in its abilities to assist companies in breaking into fresh new markets. In the Rehfeldt Group's first venture into the rail industry the company successfully led Bombardier Transportation against French, German, and Japanese train manufacturers, winning its first project in Taiwan after Bombardier had been trying by itself for years.

In 2005, at the request of the Abu Dhabi authorities, the company brought Chinese construction companies into the U.A.E. In 2006, the Rehfeldt Group helped Beijing Construction Engineering Group win its first projects in Abu Dhabi.

In 2008, the company introduced Farglory, Taiwan's largest land development company to the United Arab Emirates. Far Glory broke ground, June 26, 2013, on the first of eight plots it is developing on Abu Dhabi's new Central Business District on Al Marya Island.

Also in 2012 the company commenced its commodities trading programs as it began to pursue various joint ventures in energy production, mining and chemical products. It is collaborating with energy producers, major refiners, bunker traders, maritime companies and international commodities traders around the world.

From corporate headquarters in Taipei, the Rehfeldt Group supports a highly experienced, well-trained staff of marketing specialists recruited from top universities, major international companies and top level government entities.
